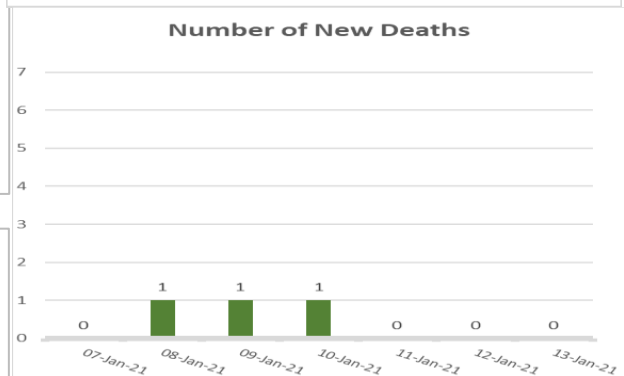
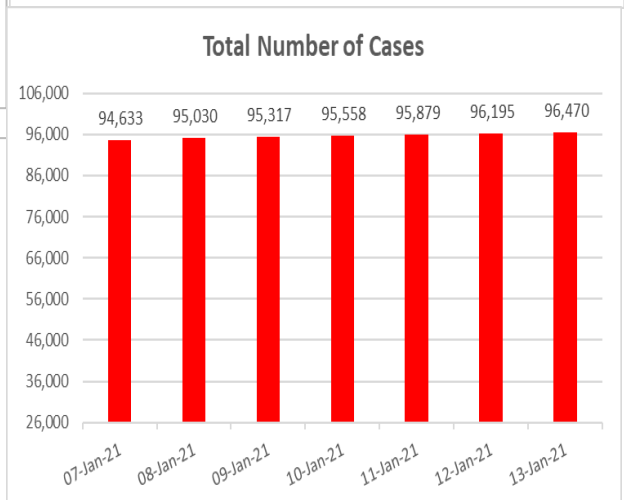
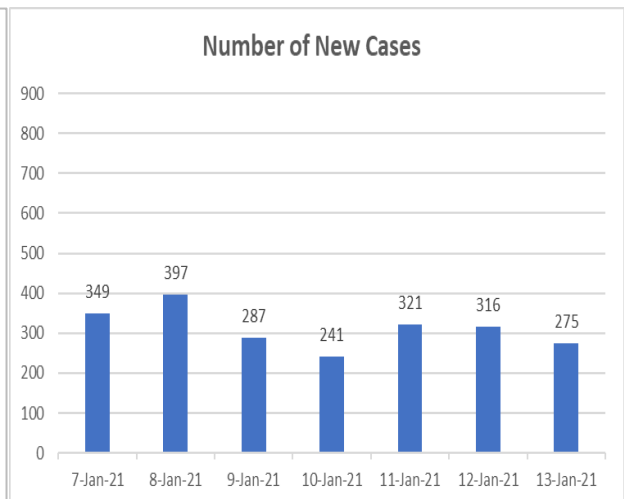

HIGHLIGHTS

- Increasing number of citizens and residents continue to take COVID-19 vaccine in Bahrain; and Ministry of Health (MOH) revealed that total number of individuals vaccinated as of 13 January 2021 is 101,363.
- MOH announced that COVID-19 Mobile Vaccination Units are being rolled out across the kingdom for the elderly and people with special needs.
- An assessment by the Bahrain Chamber for Commerce and Industry (BCCI) showed that the coronavirus pandemic has decreased economic contributions of various sectors to the GDP of Bahrain last year.
- An estimate showed that Bahrain's tourism industry suffered BD 1 billion loss due to COVID-19 Pandemic.
