Situation Report No. 67 - Kingdom of Bahrain

Data as reported by national authorities by 23:59 local time 3 June 2020

HIGHLIGHTS

- Approximately 337,800 PCR tests were conducted.
- 504 newly confirmed cases, bringing total to 12,815; 126 (25%) of them are nationals.
- At present there are 5,385 active cases, 10 of them in critical condition.
- 3 cases recovered bringing total individuals recovered to 7,410.
- 1 new mortality, a 37 year old male expat. suffering from underlying health conditions.
- Friday prayer supposed to be restarted on 5 June is postponed until further notice.
- MoH: increasing situations where wearing a face mask is mandatory to include all public places except when driving private car.
- MoH: the increase of COVID-19 infections observed lately among nationals is related to family and social gatherings during Ramadan and Eid.
- Increasing capacity of quarantine, and isolation and treatment facilities as planned, currently: total quarantine beds are 3,410 (599 occupied), total isolation and treatment beds are 7,187 (4,884 occupied)
- WHO released two new documents: key planning recommendations for mass gatherings in the context of COVID-19; and, technical guidance for the prevention and control of COVID-19 across long-term care services (see links below).
- WHO lists all candidate COVID-19 vaccines in various stages of development without endorsing any of them (see link below).

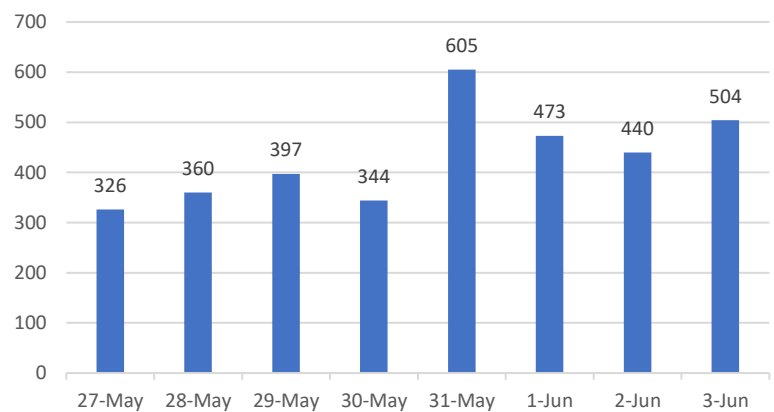
