



#### **INCIDENCE & DEATHS BY DATE**




#### **TOTAL CASES & CASES PER MILLION POP.**




Pakistan reported **1,708** new cases of COVID-19 on **10 November 2020**. The total number of cases notified since the beginning of the outbreak is **348,184** with **7,021** deaths **(CFR: 2.02%)**. Out of the total **21,098** currently active cases, **1,237** cases are hospitalized.

WHO Country representative Pakistan, Dr Palitha Mahipala, Federal minister and Special assistant to the Prime Minister on Social Protection, Dr Sania Nishter, and the Parliamentary Secretary for Ministry of National Health Services, Regulation and Coordination, Dr Nausheen Hamid participated in the inauguration.

The objective of the meeting is to finalize and updated the current national action plan and build consensus among all key stakeholders on necessary regulatory, legislative and administrative actions required for TFE elimination in Pakistan.
