PAYMENT TERMS

Payments will be made in cash or to the Bank account specified in the Notification Letter within a maximum period of (3) working days from the receipt of the Notification Letter. Failure to do this will result in the item to be awarded to the second-best bid and so on.

REMOVAL OF THE ITEMS

The Purchaser shall ensure that the purchased items are removed from their location within ten (10) working days from the date of the acknowledgement of receipt of the payment. Failure to comply, will allow WHO the option to cancel the sale of the item and regain ownership of the item. Additionally, the item may be sold to other Bidders.

The Purchaser acknowledges that WHO is unable to provide any assistance, either mechanical or manpower, for the removal of the item.
