Tunisia

Global School Personnel Survey (GSPS)

FACT SHEET

The Tunisia GSPS includes data on prevalence of cigarette and other tobacco use as well as information on attitudes on school policy toward tobacco use, access to teaching materials and training, and attitudes toward tobacco use. These factors are components Tunisia could include in a comprehensive tobacco control program.

The Tunisia GSPS was a school-based survey of school personnel from the schools that participated in the 2001 Tunisia GYTS. The GYTS was conducted in schools having students in grades 7th, 8th, and 9th.

For the GYTS, a two-stage cluster sample design was used to produce representative data for all of Tunisia. At the first stage, schools were selected with probability proportional to enrollment size. At the second stage, classes were randomly selected and all students in selected classes were eligible to participate. The school response rate was 100.0%. For the GSPS, 71.2% of the school personnel completed the survey, for a total of 711 teachers and administrators.

Prevalence of Tobacco Use among School Personnel

- 49.2% ever smoked cigarettes (Admin = 74.6%, Teachers = 47.6%)
- 34.3% currently use any tobacco product (Admin = 52.6%, Teachers = 33.2%)
- 33.6% currently smoke cigarettes (Admin = 51.9%, Teachers = 32.5%)
- 18.1% currently use other tobacco products (Admin = 25.4%, Teachers = 17.7%)

School Policies Prohibiting Tobacco Use

- 97.4% agree schools should have policy prohibiting tobacco use among students
- 35.4% report school has policy prohibiting tobacco use among students
- 75.0% agree schools should have a policy prohibiting tobacco use among personnel
- 23.7% report school has a policy prohibiting tobacco use among personnel
- 46.8% report school enforces policies on tobacco use for students and personnel

Access to Teaching Materials and Training

- 82.2% think teachers need specific training to help students avoid tobacco use
- 14.4% teachers have access to teaching materials on tobacco use
- 5.3% teachers had ever received training on youth tobacco use prevention
- 28.3% schools use non-classroom programs to teach youth tobacco use prevention

Attitudes

- 98.9% think smoke from others is harmful to them
- 92.8% think teacher tobacco use influences youth tobacco use
- 94.1% think tobacco product advertising should be completely banned
- 71.9% think the price of tobacco products should be increased
- 86.0% think the tobacco industry deliberately encourages youth to use tobacco

Highlights

- More than one-third of school personnel currently use any tobacco product; 33.6% currently smoke cigarettes and 18.1% currently use other tobacco products.
- Over one-third schools have a policy prohibiting tobacco use among students; Nearly one-quarter have a policy for personnel; Close to half of the schools enforce their policies.
- 14.4% of teachers have access to teaching materials on tobacco use.
- 5.3% of teachers have ever received training on youth tobacco use prevention.
- Over one-quarter of the schools use non-classroom programs to teach youth tobacco use prevention.
- More than nine in 10 think teacher tobacco use influences youth tobacco use.
